HMIS - What is it?

A Homeless Management Information System (HMIS) is a local information technology system used to collect client-level data and data on the provision of housing and services to homeless individuals and families and persons at risk of homelessness. Each Continuum of Care (CoC) is responsible for selecting an HMIS software solution that complies with HUD's data collection, management, and reporting standards.



Social Determinants of Health

Areas that have a major impact on people's health, well-being and quality of life.

Such as:

- Safe housing, transportation, and neighborhoods
- Racism, discrimination, and violence
- Education, job opportunities, and income
- Access to nutritious foods and physical activity
- Polluted air and water
- Language and literacy skills

Homeless outreach and access points connect Veterans to care, services, supports, and housing.

Federal Definition of "Homeless"

- An individual who lacks a fixed, regular, and adequate nighttime residence; and
- An individual who has a primary nighttime residence that is—
 - A supervised publicly or privately operated shelter designed to provide temporary living accommodations (including welfare hotels, congregate shelters, and transitional housing for the mentally ill
 - An institution that provides temporary residence for individuals intended to be institutionalized; or
 - A public of private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings



Ending Veterans Homelessness; It Takes A Community

Understanding Why?

- ► It works! Our community connected **517** individual clients to supports other than shelter in the last 12 months!
- Self-Report Primary Reasons for Homelessness
- Economic and loss of job: 28%
- ► Evicted: 12%
- ► Relocated: 12%
- ► Family Dispute: 11%

What is Diversion?

A strategy that resolves homelessness by helping people experiencing a housing crisis and/or seeking shelter identify immediate alternate housing that is <u>safe</u> and <u>appropriate</u> through crisis intervention <u>problem-solving conversations</u>. This strategy is aimed at averting shelter entry and the trauma of homelessness immediately.

Rapid Exit

The sooner you can exit someone from the shelter system the better the outcome.

Problem solving conversations focusing on solutions



The Human Experience

- What's it like experiencing a housing crisis, or any crisis?
- What sort of thoughts and emotions are experienced?
- What route do I take?

The Helper Experience

☐ What sort of thoughts and emotions are experienced from the helper or social worker's experience?

Housing First

- Few to no programmatic prerequisites to permanent housing entry
 - Permanent supportive housing's admissions policies are designed to "screen-in" rather than screen-out applicants with the greatest barriers to housing
- Rapid and streamlined entry into housing
- Supportive services are voluntary, but can and should be used to persistently engage tenants to ensure housing stability
- Practices and policies to prevent lease violations and evictions
- Tenants have full rights, responsibilities, and legal protections

When Housing First does not work?

- What is the pathway back to housing first?
- "Housing First" is not a clinically therapeutic path for the Veteran at this time because of various reasons.

Veterans Pathway Back to Housing:

- Veteran to complete outpatient (OP) program
- ► VAMC/community MH services addressing symptoms related to psychosis, delusional thoughts, major depression suicidal ideation.
- Participate in money management such as fiduciary / rep payee / guardianship.
- Veteran to participate in Behavioral Management Agreement (BMA) which outlines:
 respect for staff, no Substance Abuse, No fighting
- ► If Veteran declines the discussed options: CASS, I-HELP, Be Connected, Crisis Line etc., encouraged to contact the CRRC for his/her future needs
- Harm Reduction Services

Person First Language

Instead of Using	Use	
Addict, Abuser, Alcoholic, Junkie, Drunk, Former/Reformed Addict	Person who uses drugs, Person with substance use disorder, Patient, Person in recovery	
Habit	Substance use disorder	
Abuse	Use or Misuse	
Clean	Testing negative/non-reactive, Not actively using drugs, Being in remission or recovery	
Dirty	Testing positive/reactive, Person who uses or injects drugs	
Addicted Baby	Baby with neonatal opioid withdrawal, Baby with signs of withdrawal from prenatal drug exposure, Newborn exposed to substances	
Opioid substitution or replacement therapy	Pharmacotherapy, Medication treatment for opioid use disorder
